GUIDELINES COVID-19 2020

- ALL TRAINERS ARE REQUIRED TO BRING BACK A NEGATIVE COVID-19 TEST RESULT TO BEGIN WORKING.
- ALL TRAINERS ARE TO WEAR MASKS WHILE ON SITE.
- EQUIPMENT WILL BE DISENFECTED BEFORE AND AFTER USE. HORSES WILL ALSO BE CLEANED BEFORE AND AFTER BEING RIDDEN.
- TRAINERS ARE TO MAKE SURE THEIR RIDER CLEANS/DISENFECTS THEIR EQUIPMENT AFTER USE.

- ALL RIDERS MUST WEAR MASK UNTIL MOUNTED ON HORSE.
- ALL RIDERS ARE TO WASH HANDS BEFORE AND AFTER ARRIVING TO FARM.
- ALL RIDERS ARE TO STAY WITHIN 6 FEET APART (1 FULL HORSE).
- RIDERS ARE TO WASH DOWN HORSES WITH GIVEN SHAMPOO/SPRAY AFTER THEIR LESSON.
- ALL RIDERS ARE TO STAY WITHIN 6 FEET APART (1 FULL HORSE).
- RIDERS ARE REQUIRED TO CLEAN/DISENFECT EQUIPEMENT AFTER USE.

- ONLY ASSIGNED RIDERS, EMPLOYEES, AND BOARDERS ARE ALLOWED IN BARN AND BARN AREAS; PARENTS/GAURDIANS AND OTHER VISITORS ARE TO STAY IN THEIR CARS AND WILL NOT BE ALLOWED NEAR BARN AREAS.

IF YOU OR YOUR CHILD HAVE BEEN EXPERIENCING FLU-LIKE SYMPTOMS OR IF YOU HAVE BEEN AROUND SOMEONE WHO TESTED COVID-19 POSITIVE PLEASE LET US KNOW, WE WILL HONOR YOUR MAKE UPS.

PARENTS PLEASE MAKE SURE YOUR CHILD UNDERSTANDS ALL PROCEDURES LISTED ABOVE, WE ASK ALL PARENTS TO RUN THROUGH THIS LIST WITH THEIR CHILD BEFORE ARRIVING TO THE FARM.
